The Management Board of RAFAKO S.A. of Racibórz (the "Company") announces that on September 2nd 2018 the following changes were made to the Company's Management Board:

- 1. The Supervisory Board removed Mr Jarosław Dusiło from the position of Vice President of the Company's Management Board,
- 2. The Supervisory Board appointed Mr Jerzy Ciechanowski to the Company's Management Board as its Vice President,
- 3. The Supervisory Board delegated Ms Helena Fic, Chairperson of the Supervisory Board, to serve as President of the Management Board for a period of three months.

The Supervisory Board also decided to announce a competition for the position of President of the Company's Management Board.

Following the changes, the RAFAKO Management Board comprises:

- 1. Ms Helena Fic, delegated from the Supervisory Board to temporarily serve as President of the Management Board,
- 2. Ms Agnieszka Wasilewska-Semail, serving as Vice President of the Management Board,
- 3. Mr Jerzy Ciechanowski, serving as Vice President of the Management Board.
